### A. Meth Updates:

 Continued DHHS removals due to meth; BCSD still running into meth issues as is Adult Probation and Parole. DHHS had a recent Meth Awareness Training from D/Lt. Tony Saucedo, MSP/SWET.

- ii. Julie Nakfoor Pratt will be visiting some townships to discuss Public Act 281, 282, and 283 (Medical Marihuana). Julie also reported she has invited Ken Stecker from the Prosecuting Attorneys' Association of Michigan and Muskegon County Prosecutor DJ Hilson to present on Michigan's Medical Marihuana Facilities and Licensing Act to elected officials, municipal managers, and law enforcement. The Learning Forum is set for June 7, 2017, and registration will by invitation through an online system.
- iii. Achiles Malta shared the Kalamazoo SATF has prepared a document requesting clarification on Public Acts 281 and 282; he will forward the document.
